



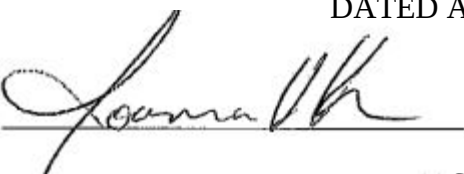
NOTICE OF PUBLIC MEETING SATORI GOVERNING BOARD
