



NOTICE OF PUBLIC MEETING SATORI GOVERNING BOARD

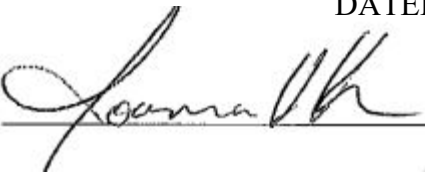

Call to the Public-- Pursuant to A.R.S. 38-431.01.G, the Governing Board may allow individuals from the public to address the Governing Board.
