



NOTICE OF PUBLIC MEETING SATORI GOVERNING BOARD

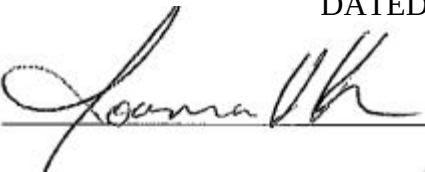

Pursuant to A.R.S. 38-431.03.A.2 and A.3, the Governing Board may vote to go into Executive Session, which will not be open to the public, for discussion, or consultation for legal advice concerning any item on the agenda or to review, discuss, and consider records exempt by law from public inspection, including the receipt and discussion of information or testimony that is specifically required to be maintained as confidential by state or federal law.

Persons with a disability may request a reasonable accommodation such as a sign language interpreter, by contacting Joanna Honea. Requests should be made as early as possible to allow time to arrange the accommodation.
